



# Privacy Notice to livestock suppliers of KLS Ugglarps AB

During your cooperation with KLS Ugglarps AB, we will process your personal data.

In the following, you will find information on the personal data we are processing about you in relation to your cooperation with KLS Ugglarps AB concerning your delivery of livestock, the purposes for which the data are processed, the basis for the processing, erasure, etc. You will also find a description of your rights under the General Data Protection Regulation (GDPR).

## **Who is the data controller?**

The following undertaking is responsible for the lawful processing of your personal data:

In the following referred to as “KLS” or “we”.

## **Types of personal data**

We process the information, including personal data, which we receive in connection with your deliveries to KLS.

Specifically, we process the following information:

- Contact information, hereunder name, address, e-mail etc.
- Account number
- Company registration number
- Supplier number
- Slaughtering data

## **Purposes of processing personal data**

The main purpose of processing the personal data about you is to manage your payment and ensure correct data is transferred to the abattoirs/public authorities.

## **Legal basis for Danish Crowns processing of personal data**

The legal basis of the General Data Protection Regulation (GDPR) for our processing of personal data about you is as follows:

- processing is necessary for the performance of a contract, see Article 6(1)(b) of the GDPR
- processing is necessary for compliance with a legal obligation, see Article 6(1)(c) of the GDPR

We may also process your personal data on the basis of our legitimate interests e.g., prior to entering an agreement with you, see Article 6(1)(f) of the GDPR

### **How long do we store personal data?**

We will store personal data as long as our business relationship exists and for as long as the purpose for which the data was collected for is relevant.

Certain personal data, hereunder personal data in our ERP system SAP, will be stored for 10 years or as long as the purpose for which the data was collected for is relevant.

If you or your company choose to terminate the cooperation with KLS, we will store your personal data for the following five years.

### **Security**

KLS has implemented technical and organizational measures to ensure our processing of personal data against accidental or illegal destruction, loss alteration and unauthorized disclosure or publication. We also require that trusted third parties who process your personal information on our behalf, have implemented such measures as well.

Employees are instructed in how they may process personal data, and internal guidelines have been adopted for what to do in the event of a breach.

### **Recipients**

We may share or disclose your personal data with the below categories of third parties:

- a) entities in the Danish Crown group;
- b) relevant employees in the Danish Crown group;
- c) Public authorities such as the Swedish Board of Agriculture;
- d) data processors e.g., IT-systems, hosting and security companies which are assisting with our business activities;
- e) customers who require information in relation to traceability;
- f) abattoirs; *or*
- g) other third parties with your prior consent or if they are involved in a merger, demerger or a sale which involves all or part of our business or assets.

KLS may engage other third-party service providers that will have access to and process your personal data. If such third-party service providers process your personal data outside of the EU/EEA which is not ensuring an adequate level of protection, the transfer will be subject to the European Commission's Standard Contractual Clauses (EU) 2021/914, see Chapter V of the GDPR.

### **Your rights**

Subject to certain exemptions set out in the General Data Protection Regulation (GDPR), you have the following rights in respect of your personal data:

1. the right to obtain a copy of the personal data collected about you and to transmit said copy to another data controller;
2. the right to update or amend the personal data collected about you if it is inaccurate or incomplete;
3. the right to erase, or restrict the processing, of the personal data collected about you



4. the right to object to the processing of the personal data collected about you, including in respect of any data processed for direct marketing purposes;
5. the right to withdraw any consent you have provided in respect of our processing of your personal data; *and*
6. the right to lodge a complaint with the competent supervisory authority
